**COST:** There is a 300 MXP (plus tax 15%) Business Kit fee that includes:

- A personalized website with online business tools
- Business Kit that includes promotional materials and information to introduce you to Freeliflife

**FORMS:** All forms are available online and are also included in the Business Kit. Forms can be submitted by regular mail, fax, or scan and emailed directly to FreeLife Mexico.

- Copy (front and back) of your Voter ID Card

### HOW TO PURCHASE

**COST:** Independent Distributors make their product purchases directly from FreeLife Mexico or through a local DC. Please note DCs are independent from FreeLife Mexico.

\*DC's are able to set their own Price. These prices do not include VAT, nor shipping and handling \*

**PAYMENT OPTIONS:** Payments can be made using: major credit card (Visa or MasterCard), HSBC Debit Card (online or by phone), other debit card (only at Monterrey office), and Bill Pay at HSBC, Bancomer or Banamex. Purchases through a DC are subject to their payment terms.

- Credit Card (Visa, Master Card o American Express).
- Debit Card HSBC (on line or phone).
- Other debit cards (only available in Monterrey office).
- Bill Pay in HSBC, BANAMEX or BANCOMER.

**DELIVERY:** Purchases can either be shipped using Estafeta ground service (3-5 business days from when payment is received) or they can be collected at one of our designated pick up locations. Purchases made through a DC are collected from that individual.

The cost of shipping and handling varies according to the option you select:

- Shipping Cost: Fixed part of \$35.00 plus a variable part of 3.1% form the total of the order plus VAT

## GETTING PAID

Direct Deposit is the fastest and most convenient way to receive your commission payment. The only requirement is that you have a Mexican Bank Account (CLABE) – we do the rest.

You can also elect to use our DAP (Dispersión Automática de Pago) method. To use DAP:

- You are required to go into your local HSBC bank to withdraw your funds in person.
- You will need to contact Customer Service to receive your reference number – this number is unique and will be needed each time before you go to the bank to collect your earnings. Earnings cannot be collected without this number.
- You will be required to show identification (Voter ID Card)
- It is important to mention the HSBC representative you need to collect a DAP.
- Dap payments expire after 90 days if is not collected before the expiration date you would need to provide a Bank account (CLABE) to receive your commission.

In order to collect your earnings through Direct Deposit or OTC:

1. Select your commission payment method (Direct Deposit or OTC)
2. Fill out and sign the Commissions Payment Form
3. Fax (01-800-087-5433) or mail your Commission Payment Form to FreeLife Mexico

Commissions will be available each month no later than the 20th of the month.

The minimum amount to release commissions payment is \$55 pesos (5 USD) for Direct Deposit and \$220 pesos (20 USD) for DAP (OTC). Depending on the payment method, if you generate less commissions than the amounts mentioned, these will be held until the minimum amount has been gathered.
